It was noted that due to previous commitments Ms M. Dillion was sadly unable to attend but would duly sign the 'Declarations of Acceptance of Office' before the Clerk, prior the start of the next Parish meeting.

5. Upper Recreation Ground opening

[JA159:19] The Chairman, Cllr G. Wenham, spoke to inform the members of previous discussions that had taken place to consider holding the opening of the newly refurbished Upper Recreation Ground on Friday 5th July 2019.

Concerns were raised via Cllr R. Thorne in regards to the short timescales involved to organise this event, to which the Chairman Cllr G. Wenham agreed with, expressing his own apprehensions that no budget had been set either to hold this event.

Cllr P. Hudson spoke to request the members consider postponing the opening until after the children had broken up for the school holidays to enable more children to attend, however other members cited that this could also work against them, as it was well known that many families jet straight off for holiday after the schools break up to take advantage of the 'lower cost' holidays before the peak holiday season begins in August.

A discussion ensued between the members in regards to the possible dates and budgets, where it was proposed via ClIr T. Dolby to hold this event on Saturday 20th July, starting from 11.00am with a prospective budget of £350.00, which would need to include a free ice-cream for all the children in attendance. This proposal was seconded via ClIr S. Chamberlain and unanimously agreed.

Cllr C. Buckwell also spoke to advise that following his connections as Ward Councillor for Strood South that he would personally speak to both the Mayor and the Deputy Mayor of Medway to check their availability in order to invite them to this event and to ask them if they would be willing to officially open it. Cllr C. Buckwell advised he would report back to the Clerk once he had heard back from either of the Mayors.
